Conditions of Adoption

As a condition of adoption of this animal, I agree to comply with Chapter 6.08 and 6.12 of the Douglas Municipal Code and the following terms of this contract. I understand that non-compliance with any of the terms of this agreement may result in revocation of my animal ownership rights, including seizure of the animal, and legal enforcement of its terms.

- An adoption fee of _____ will be collected at the time of adoption. I understand that I may return the animal within seven (7) calendar days for a refund. Vaccination records, tags, and collars must be returned with the animal or charges may apply. After seven (7) days I understand there will be no refund of the adoption fee.
- I agree to keep and care for this animal as a pet in a lawful and humane manner and provide appropriate shelter and medical care, including but not limited to all vaccinations, required to keep the animal healthy for the duration of its life.
- If I am unable to keep and care for this animal, I agree to return it to Laramie Peak Humane Society if space is available at the shelter at the time of return. Should space be unavailable I agree to rehome or surrender to a no-kill facility.
- I certify that I have never been convicted of any Municipal Code or County Regulation involved with cruelty to animals' violation, similar to that defined by Douglas Municipal Code 6.04.060.
- I acknowledge that Laramie Peak Humane Society, its staff, and board of directors, cannot guarantee the temperament, health or disposition of any animal and will not be held responsible for any damages that may occur after the release of the animal to the adopter.
- I understand that Laramie Peak Humane Society personnel or designee shall be allowed to contact me several times over the next three (3) months to verify the animal's general welfare.
- I authorize Laramie Peak Humane Society personnel or designee to verify the information provided on this form. I understand that if I rent my place of residence, my landlord will be contacted solely for the purpose of establishing my authority to keep a pet on the premises.
- I agree to be responsible for any legal fees resulting from enforcement of this agreement.

I have read and understand the foregoing adoption agreement and acknowledge that it is a binding legal agreement. I agree to abide by the terms set forth above.
